If the Trainee is required to work on PH, the Trainer would need to compensate the Trainee for the day(s) worked. - During training, Trainees are not insured. All medical expenses will be borne by the Trainees themselves. - Trainees will receive a training allowance of S\$1,600 upon completion of the training. - Trainees are required to complete a minimum of 75% attendance to be eligible for the training allowance. - Upon successful completion of the training, the Trainee will receive a stable groom certification by STAR.
