- (i) must declare **ANY** period of disqualification and any suspension imposed on me for a continuous period of three months or more in Singapore or elsewhere:
- (ii) undertake to furnish, **through** the relevant Racing Authority, confirmation of current standing on any Jockey's Premiership, together with a valid riding clearance. In the case of an application to ride in Singapore for the first time, **full** disciplinary records must be supplied through the Racing Authority;
- (iii) must be able to furnish, with this application all the required documents, in full, at least **nine** days before the first day of the Race Meeting;
- (iv) shall bear all associated costs incurred eq. airfare, accommodation etc;
- (v) agree to be bound by the Rules & Regulations of the MRA and the Club and accept that the Club reserves the right to reject this application or withdraw the permit **for any reason whatsoever at its sole discretion**;
- (vi) give authority to have any fines imposed by the Singapore Turf Club that is not a subject of any appeal proceedings to be deducted from my earnings and made payable to the Malayan Racing Association; and
- (vii) am responsible for my own medical costs, if injured, should I not be covered by medical insurance*.
 - *Medical expenses will be paid for by the MRA for injuries sustained by registered Jockeys / Riders when riding trackwork or in races under the terms stipulated in MRA Regulation 36.4.
